- a. All art must be brought to the Braxton Condominiums Thursday, June 6th between the hours of 4pm to 7:30 pm.
- b. All artists must be present at the Gala, Friday June 7th from 5:30 to 10pm
- c. 2d artists must provide their own easels for exhibiting their work
- d. 3d artists must provide any cloths, pedestals, and whatever means necessary for proper display of their work. Some flat surfaces may be available for display... TBD.
